Section 125 Deductions Include – Health Premium, Cancer/Accident, Hospital, Medical Expenses, and Childcare.

Schedule for deductions are as follows:

Section 125 Health Prem, Cancer/Accident, Hospitalization, Disability Premiums, AUL Supplemental Life - 19 Deductions (Beginning 9/16/11–Ending 6/8/12).

**Deductions for Health Premium will not be taken on 1/6/12 pay, and a premium holiday is planned for 1/20/12.

Section 125 Medical Expense, Childcare – 20 Deductions (Beginning 9/16/11–Ending 6/8/12, deduction will be taken on 1/6/12).

Credit Union, and 403(b) – 26 Deductions

U.S. Savings Bonds – 13 Deductions (every other pay beginning 9/16/11).

United Way - 19 Deductions (Beginning 1/20/12 – Ending 12/21/12) - No deductions from 6/22/12 through 8/31/12 pays.

Dues - 20 Deductions (Beginning 9/16/11 – Ending 6/8/12).

EACS Foundation – 20 Deductions (Beginning 9/16/11 – Ending 6/8/12).
