
RESOLUTION NO. 16-23

A RESOLUTION EXPRESSING THE PROPERTY TAXATION POLICY OF USD 316 GOLDEN PLAINS WITH RESPECT TO EXCEEDING THE REVENUE NEUTRAL TAX RATE FOR FINANCING THE ANNUAL BUDGET FOR 2022-2023


Whereas, 2022 HB 2239 amending K.S.A. 79-2988, provides that a levy of property taxes to finance the 2022-2023 budget of USD 316 exceeds the Revenue Neutral Tax Rate to finance the 2022-2023 budget of USD 316, be authorized by a resolution.

NOW, THEREFORE, BE IT RESOLVED by USD 316 that the 2022-2023 budget with a levy of property taxes exceeding the Revenue Neutral Tax Rates calculated for 2022-2023, as adjusted pursuant to 2022 HB 2239 amending K.S.A. 79-2988 is hereby adopted.
