**A RESOLUTION
REGARDING THE GANN AMENDMENT**

WHEREAS, in November 1979, the California electorate did adopt Proposition 4, commonly called the Gann Amendment, which added Article XIIB to the California Constitution; and

WHEREAS, the provisions of that article establish maximum appropriation limitations, commonly called "Gann Limits" for public agencies, including Central Union School District; and

WHEREAS, The Central Union School District must establish a Gann Limit for the 2021-2022 fiscal year and estimate a limit for 2022-2023 in accordance with the provisions of Article XIIB and applicable statutory law;

NOW THEREFORE BE IT RESOLVED, that the Central Union School District does provide public notice that attached calculations and documentation of the Gann limits for the 2021-2022 and the 2022-2023 fiscal years are made in accord with applicable constitutional and statutory law; and

BE IT FURTHER RESOLVED that the Superintendent provided copies of the resolution along with appropriate attachments to interested citizens of this District.

The foregoing Resolution, **#S-09-12-2022**, was adopted at a regular meeting of the Board of Trustees of the Central Union Elementary School District on this 12th day of September 2022, by the following vote:
