## 2021-22 School Overview

The annual School Accountability Report Card provides us with the opportunity to share information about Don Pedro Elementary School in Ceres, Ca.

Don Pedro Elementary is one of fourteen elementary schools in the Ceres Unified School District located in Stanislaus County, one of the largest agricultural areas in the world; approximately 90 minutes from San Francisco. Don Pedro Elementary is a TK, K-6 school operating a Title I School-wide Program on a modified traditional calendar. The school's population totaling approximately 550 students is assigned to 13 primary classrooms, 7 intermediate classrooms. Class size reduction has been implemented in all K-3 classrooms with a maximum of 24 students per class. In addition to its TK-6th gr classrooms, state preschool and a regional specialized class for 4-5-6 grade students operate on site. Ninety-three percent of the student population is eligible to receive free and reduced price meals. Don Pedro Elementary has a diverse student enrollment with fifty-four percent of the student population identified as English Learners, the majority of those having Spanish as a primary language. English Learners at the school have been assigned to appropriate programs with qualified staff providing instructional services. The school facility includes a library and learning center. The site has wifi Internet access and every student has a technology device. Each individual classroom has technological equipment to assist with instructional delivery. These items include: student chromebooks, class projector, document camera, and tablet. Students may also checkout a wifi hotspot in order to support home internet access. All of these devices and equipment are also used to support student distance learning. Students are provided additional support through on-site extended day activities addressing academics, enrichment, and recreation.

The school district held a public hearing on September 17, 2020, and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs. the State of California. All students, including English Learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home.

Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the State are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption.

- Monitor their child's school work and provide support by establishing a quiet study place at home and scheduling regular time to study and read together daily.
- Maintain two-way communication with the school. All staff can be readily contacted in person, via telephone, hand-delivered notes, email or direct messaging via the Parent Square app. School notices are sent home as reminders within the weekly Wednesday folder, and a monthly newsletter, contains up-to-date school events calendars. In addition, the staff and families participate utilize the parent square app to send and receive postings of school events and communicate through text. In addition, Back-to-School Night, parent conferences, and Open House are important avenues for parent contact.
- Take an active role in the school by participating in our monthly parent coffee meetings, parent support groups, School Site Council, and/or English Learner Advisory Committee. Parent meetings share community resources with families on topics such as: nutritional family meals, social-emotional learning, community health and education resources.
- Make special events at school a family affair by attending Family Nights and student performances.
- Honor student success by acknowledging recognitions at our morning assembly, DP Live!, student recognition through Dolphin of the Week and Student of the Month as well as monthly "zero day" celebrations of perfect attendance and behavior.

- Serve as a classroom volunteer or chaperone on field trips, permitting safety regulations.
- Support school-wide fundraisers and community drives including the annual Jog-a-Thon, Fall Carnival, Winter holiday events, movie night and other family events.

## Professional Development

Staff development is a critical component to teacher and student success, and Ceres Unified School District is dedicated to a variety of professional development opportunities for staff. Each year, at least three work days on the school calendar are dedicated to staff development. Staff also have professional learning opportunities covered through substitute teacher coverage as well as opportunities to attend summer and after school learning opportunities. In addition, 240 minutes of after school time is dedicated to department and grade level meetings, for teachers to collaborate, learn strategies, and develop action plans to meet identified student needs. Grade level teams work collaboratively to ensure the implementation of common curriculum and learning expectations. Grade level collaborations are supported through monthly meetings and release time.

Professional Development opportunities have afforded teachers the opportunity to receive additional training related to: lesson design and delivery of district instructional norms to maximize student engagement during instruction; district adopted curricular resources; professional learning community processes; unit planning, assessment literacy and student investment knowledge; response to intervention structures and procedures; reading & math strategies and instruction; as well as visible learning research as it relates to the CUSD Framework For Learning.

District coaches have provided classroom demonstrations and workshops, as well as lesson study professional learning in support of the school's established goals. Classroom visitations have been equally valuable giving grade-level teams the time to view curricular areas of interest and debrief during a subsequent planning time. In addition, educational consultants led professional learning seminars for staff periodically throughout the school year.

The District participates in an Induction program and other county and state approved formal training programs dedicated to improving teacher quality. In addition, the district fully supports classroom teachers with a cadre of full time staff developer/coaches who can assist with the implementation of curriculum and strategies.

School sites must include a professional development plan and budget in their school site plan. Activities can include attendance at summer institutes, after school or Saturday workshops, teacher release days to attend conferences, and grade level or department release days for in depth professional development. All professional development is aligned to the district strategic plan. The goal of all professional development is to increase student achievement.

Grade level teams work collaboratively to insure the implementation of common curriculum and learning expectations. Grade level collaborations are supported through monthly meetings and release time.

With the pandemic beginning spring of 2020, teachers have participated in hours of training in using platforms to support remote learning and student/family communication. Instructional coaches and the educational technology specialists supported increased professional learning with using technology to support learning at a distance.

In each school year, the site has at least 5 full days appointed to professional learning for each teacher. These dates include full day professional development on designated district days as well as partial release days where staff participate in learning sessions with educational consultants, district instructional coaches as well as collaborative grade level learning sessions.
