2021-22 School Overview

School Mission

The Westport community is dedicated to provide an equitable, nurturing, and safe environment where students are empowered with high level learning in order to make choices as lifelong learners.

Westport Elementary School is located nearly ten miles from the City of Ceres and is a part of the Ceres Unified School District. The school is one of the smallest of the fourteen elementary schools in the district; however, it pulls from the largest area. The culture at Westport is diverse. Students come from rural farms and small housing areas surrounded by the mostly agricultural landscape of orchards and dairies. A large portion of our population comes from an unincorporated area in South Modesto that is eight miles from the school. All students are eligible to ride the bus to and from school, and most do. The school year consists of 180 instructional days with seven minimum days for parent conferencing and three for staff professional learning.

Westport Elementary School's population of approximately 416 students is assigned to 12 primary and 9 intermediate classrooms. Of the 416 students, 53.79% of the students are English Learners, the majority of those having Spanish as a primary language. In addition to its K-6 classrooms, there is a preschool program present on campus. The preschool program runs a morning and an afternoon session. Each session has approximately 12 students.

2021-22 Quality, Currency, Availability of Textbooks and Other Instructional Materials

The school district held a public hearing on September 17, 2020, and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs. the State of California. All students, including English Learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home.

Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the State are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption.

Statewide Assessments

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and

Options

We welcome and encourage family involvement at Westport Elementary School. As families become involved, their children will continue to benefit in their school achievements. Communication between school and families is very important. We provide our parents with regular communication regarding programs and events at Westport Elementary School. We communicate through our monthly newsletter, "Hoofprints," our Wednesday parent communication folders, newspaper articles, parent handbook, progress reports, Parent Square posts and messages, as well as our social media presence.

Parents attend regularly scheduled Parent Coffee and ELAC meetings where parents are introduced to school initiatives and our full time Community Liaison connects our families with a variety of community resources including health, employment, adult education, nutrition, grief and other resources as they are needed. These events also provide opportunities for school staff and parents to discuss social emotional tools they can use in the home to connect with the social emotional initiatives practiced at school.

We have School Site Council meetings, a Back to School Night, and an Open House. Because students at Westport Elementary School are bussed from so far away, the school is an integral part of what connects the Westport community. At Westport Elementary School, we welcome our local Rotary Club with the annual Rotary Read-In. We also invite the community to be a part of our annual Career Fair, Jog-a-Thon and Letters to Santa events. The Parent Teacher Club at Westport coordinates a carnival for our families to enjoy, and the school site hosts a family picnic to end our school year.

Safety is a top priority to the staff, families and students of Westport Elementary. The safe school plan is revised each year with the input of both staff and the School Site Council. Data is collected on school safety through annual surveys to parents, students and staff. Surveys are administered each fall, and the safety plan is revised by March each year. The last School Safety Plan was revised and approved by the Westport School Site Council on February 23, 2021.

Westport Elementary takes a proactive approach in encouraging positive student behavior through our Westport Way PBIS initiative and our Hero program which "catches students being good" and following the "Westport Way" in various areas around school. We have banners that remind students about expected behavior in various locations around campus as well as on the bus. All classified and certificated staff encourage positive behavior by rewarding safe behavior and following the Westport Way by awarding "Mustang Moolah" to our students to spend at our Hero store.

All students attend Mustang University and Mustang Round-Up monthly to review expected behaviors and discuss college and career opportunities. Students are rewarded at these assemblies for practicing the current life skill of the month and showing what it means to follow the "Westport Way."

Safety drills and procedures are practiced on a monthly basis and annual education in drug & alcohol awareness is provided by staff during Red Ribbon week activities.

In addition, Westport prides itself in having clean, safe and maintained facilities.

Professional Development

Staff development is a critical component to teacher and student success, and Ceres Unified School District is dedicated to a variety of professional development opportunities for staff. Each year, at least four work days on the school calendar are dedicated to staff development. Staff also have professional learning opportunities covered through substitute teacher coverage as well as opportunities to attend summer and after school learning opportunities. In addition, 240 minutes of after school time is dedicated to department and grade level meetings, for teachers to collaborate, learn strategies, and develop action plans to meet identified student needs. Grade level teams work collaboratively to ensure the implementation of common curriculum and learning expectations. Grade level collaborations are supported through monthly meetings and release time.

Professional Development opportunities have afforded teachers the opportunity to receive additional training related to: lesson design and delivery of district instructional norms to maximize student engagement during instruction; district adopted curricular resources; professional learning community processes; unit planning, assessment literacy and visible learning research as it relates to the CUSD Framework For Learning; response to intervention structures and procedures; and reading/math strategies and instruction.

The district provides access to the Ceres Induction Program and other county and state approved formal training programs dedicated to improving teacher quality. In addition, the district fully supports classroom teachers with a cadre of full time staff developers/coaches who can assist with the implementation of curriculum and strategies. District coaches have provided classroom demonstrations, 1:1 coaching, release days, and other training opportunities in support of the school's established goals.

School sites must include a professional development plan and budget in their school site plan. Activities can include attendance at summer institutes, after school or Saturday workshops, teacher release days to attend conferences, and grade level or department release days for in depth professional development. All professional development is aligned to the district strategic plan. The goal of all professional development is to increase student achievement.

In 2019-2020, the school site had planned collaborative professional development days in cooperation with other sites from CUSD focused specifically in the area of math practices and unit planning. Due to school closures during the pandemic, many of our professional learning plans for the spring had to be placed on hold.

In 20-21, we held PD through Zoom remotely for professional learning. Many PD plans were put on hold or modified due to school closures and hybrid learning. PLC teams met weekly in addition to 5 professional development days, with the majority of the professional learning centered around English Language Development and writing instructional practices. In addition to the school-wide support, each grade level team worked with guidance and support from the site instructional coach to further develop unit plans, along with the 10 collaboration/early release days.

Professional Development

By the end of 21-22, the school site will have had a total of 19 days dedicated to staff development and continuous improvement. The site will have provided staff development on 4 district wide days (August, November, January, March). In addition, each team will have had two half day release days with district coaches centered on literacy and math. Each grade level team will also have had 1 full day with a district instructional coach centered on unit planning for a total of 2 full days of release time. Lastly, 10 early release professional learning times are provided.
